2. The bidder should not be minor.
3. The quotation should be enclosed in a sealed cover super scribed “**Quotation for disposal of CEA Vehicles**” must reach to the Director (A-1), Central Electricity Authority, 5th floor, Sewa Bhawan, R.K. Puram, New Delhi-110066 by 3.00 PM on or before 28-02-2012. A Bank Draft from a Scheduled Bank payable to the DDO, Central Electricity Authority for an amount of Rs.5000/- (Rupees Five thousand only) should accompany the quotation as earnest money.

5. In case of successful bidder, this amount will be adjustable against the total amount required. In other cases the Bank Draft will be handed over to the bidder after finalization of tender.
